SUBJECT: FINAL SHOW CAUSE NOTICE

WHEREAS, you are alleged to have committed the following acts of misconduct within the meaning of E&D Rules 1973.

2. **AND WHEREAS**; you were served the Show Cause Notice vide No.SS/MW/1324, dated 06/12/2023 via courier on your mailing address but has not replied.

"You were requested for grant of Forty Five (45) days Earned Leaves including Ex-Pakistan Leave, sanctioned vide Head Office Letter No.SS/MW/786, dated 29/08/2023 w.e.f 01/09/2023 to 15/10/2023 and you were supposed to join your duties w.e.f 16/10/2023. But instead to join your duty, you have furnished an application for Ninety (90) days Extension in Ex-Pakistan Leaves w.e.f.16/10/2023, while you have not any Earned Leave balance at your credit".

This act on your part tantamount to misconduct"

3. **AND WHEREAS**; sufficient evidence is available on the record against you as detailed above and I, **Miandad Rahoojo, Commissioner SESSI, being your appointing and Competent Authority**, am satisfied that there is no need of holding further Enquiry.

4. **NOW THEREFORE**, in exercise of the powers conferred upon me under **E&D Rules, 1973**. I do hereby dispense with the Enquiry and call upon you Final Show Cause to reply within fourteen (14) days of the publication of this Final Show Cause Notice in press as to why any major penalty of Removal from Service under the said E&D Rules, 1973, should not be imposed upon you, failing which, ex-parte decision will be taken against you.

5. You may also intimate whether you would like to be heard in person or otherwise.
